**Amendment to Costs in Criminal Cases (General) Regulations 1986;
Statutory Instrument 2008 No. 2448**

From 13 October 2008 practitioners must send all new claims directly to the relevant office of the National Taxing Team (regardless of the date of the costs order). This will be determined by which NTT office covers those Crow Courts to which a Magistrates Court commits its' cases.

You must include your file(s) with your claim and must endorse the Court/Libra reference number on the claim (this will be found on the Defendant's Cost Order issued by the court). The order for costs made by the Court must also be attached to give the NTT authority to determine the claim.
